### Road work

The orange barrels are already up along Warren Road from Wayne Road to Newburgh, but the drive is about to get more difficult.

Beginning at 6 a.m. Monday, July 30, the intersection of Warren Road and Central City Parkway will be closed for a total pavement replacement project, according to Wayne County. The closure will continue through 10 p.m. Sunday, Aug. 19.

Motorists on eastbound Warren Road can use Hunter Road or Nankin Boulevard as alternate routes. Eastbound motorists can use Hunter or Ford Road. Detours will be posted.

### Home repairs

Moderate-income homeowners in Westland needing limited home repairs can get help through the city's Department of Housing and Community Development.

The department manages the Limited Repair Home Rehabilitation Program, which provides grants or loans to repair all home items that are needed to meet local building codes. Examples include roofs and gutters, furnaces, water heaters, windows, cement, fencing, sewer backups and basement flooding.

The program also provides grants or loans for barrier-free home access, such as installation of ramps, handrails and modifications of bathroom fixtures.

Homeowners must meet federal income guidelines, adjusted by family size. For example, the maximum income for a family of two is \$42,500 and for a family of four is \$53,100. The loan will be placed as a lien on the property, payable at the time the house is sold. The interest on the lien is dependent on family income.

If approved for the program, city staff will work with the homeowner to hire contractors and inspect the quality of the work.

The city is also accepting applications for the Emergency Repair Program, to fix or replace single items, such as a furnace or roof.

## Bodies of Westland teens found in field in Detroit

The morning after a prayer vigil was held for two Westland teens, their bodies were found in a field near Detroit City Airport — roughly five miles from the family member's home where they were last seen.

Police said the bodies were found around 9:30 a.m. Friday in a partially mowed field near Lyford Avenue, adjacent to Detroit City Airport on city's east side. The teens had been shot in the head, apparently execution style, according to Detroit police.

Detroit police officers broke the news to family members who had gathered near Joy and I-96 to resume searching for the teens near where their car had been recovered on Monday.

The Wayne-Westland Community Schools district has begun filling vacancies created by the departure of several administrators.

The school board recently approved the appointment of Aaron Baughman as executive director of the curriculum department, Kelly Kaminiski as co-principal at Marshall Upper Elementary School in Westland and Jennifer Keats as principal of Roosevelt-

McGrath Elementary School in Wayne.

Baughman has been with the district since 2001. He started as a teacher at Hoover Elementary before moving to Marshall Middle School where he taught seventh-grade English and language arts, served as an assistant principal and principal and briefly as a co-principal when the school became an upper elementary in 2010.

He move over to the district's administrative offices in September

2010, serving as director of professional development.

Baughman has a bachelor of arts degree in English and elementary curriculum from William Tyndale College and a master of science degree in administration with a major in educational leadership from Madonna University.

## Plymouth man charged in fatal motorcycle accident

A Plymouth man is facing two felony charges stemming from an accident that killed a motorcyclist and critically injured his wife.

Robert John Montgomery, 79, was arraigned Thursday on charges of operating while impaired causing death and operating while impaired causing serious injury. Police said he had a .10 blood

alcohol level at the hospital following the accident. The legal limit for drunken driving in Michigan is .08.

Gary West, 56, of Garden City was killed in the July 24 accident at Ann Arbor Trail and Hines Park Drive. His wife Susan, 54, remains hospitalized in critical condition after being transported by helicopter to the University of Michi-

mending him for the position. "He has a boatload of experience."

"Thank you for the opportunity," said Baughman. "Curriculum is where my heart is. I'm excited to have the opportunity to improve our programs."

"We're glad to have you as part of a team with a little different focus," said school board President Carol Middel. "We know you will work hard for our students."

Kaminski also joined the district in 2001 as an eighth-grade teacher at Franklin Middle School. She spent five years teaching at Taft-Galloway Elementary before returning to Franklin to be an intervention specialist. The Elementary Teacher of the Year for Wayne-Westland in 2007, she has a bachelor of science degree in elementary education from Western Michigan University and a master of arts degree in education from the University of Michigan-Dearborn.

"I'm so very proud of her, she has been an outstanding leader of our Galileo Leadership Con-

sortium," said Baracy. "I want to thank the board and my new teammates" said Kaminski. "I look forward to working hard and I appreciate the faith you have in my ability."

Baracy pointed out Keats "came up through the ranks" since joining the school district in 2002. She has been a second-grade teacher at Hicks Elementary, a first-grade teacher and Reading First literacy coach at Taft-Galloway and an intervention specialist at Stevenson Middle School.

Jimmy's Char House. It was very classy," said Dakis. "When John and I walked out, we looked at each other. I said it would be nice to open restaurants called Char House with the name of the city."

John Dakis, born in Greece, had worked his entire life in restaurants. When he was laid off from his most recent job, Cindy Dakis said her husband was tired of working for someone else.

So on Memorial Day 2011, the couple took a leap of faith and opened the Belleville restaurant. A year later, they have already had a soft opening for the Westland restaurant, a building that is stand alone and larger than their Belleville restaurant which is located in a unit of downtown building.

"It's scary in this economy - we're both 55. I've always worked with people and John's good with the restaurant part," said

Dakis. "We complement each other. I pick up the things he misses and he picks up what I miss."

The couple has been together 10 years and married for four years. It's the second marriage for both and they each have grown children.

"We've had a lot of support and we buckled down. We've got to do this. We can make it work," Dakis said. "For a married couple, running

a restaurant is more personal."

Those personal touches include the dishes on the menu - entrees also have a suggested wine pairing - and the decor. At the end of the booths, Dakis has framed historical photographs like one of Merriam Road being paved during the 1930s.

Like the Belleville restaurant, the Westland Char House features paintings done by local artists. The paintings are for sale. Dakis said she doesn't charge the artists

for displaying their paintings or selling them - she has wall space to decorate and the artists need a place to show their work.

"I like doing that. I was raised in Dexter - very small town. I like talking with people," said Dakis. "We like people and we like good food."

gan Hospital.

A not guilty plea was entered for Montgomery at his arraignment in Westland's 18th District Court. Held in lieu of \$200,000 cash bond, Montgomery is scheduled for a preliminary examination Aug. 2.

The accident happened just before 9:30 p.m., Police said the motorcycle ridden by the Garden City couple was southbound on Hines Drive.

As the motorcycle approached Ann Arbor Trail, police said a four-door sedan traveling northbound attempted to make a left turn onto Ann

Arbor Trail.

The motorcycle dropped to the pavement and began sliding. Police said the motorcycle struck the turning vehicle causing both rider and passenger to be ejected.

"I don't have the autopsy results but I would say he (Gary West) died as a result of multiple trauma," said Westland Police Officer Kevin Yudt of the Traffic Bureau.

Unlike his wife, Yudt said that Gary West was not wearing a helmet. Susan West sustained multiple injuries in the accident, Yudt said.

Montgomery has no prior alcohol-related offenses, according to police.



Thursday evening, lighted lanterns floated off into the night sky as a crowd of family, friends and well-wishers held candles and offered prayers for the safe return of two teens.

The candlelight prayer vigil was held Thursday in the parking lot of Livonia Churchill High School where Jacob Kudla, 18, and Jourdan Bobbish, 17, met and became friends.

Redford residents Dan and Erin Sisty came to the vigil with four-year old son Aidan. Erin Sisty has an older son who is a close friend of Bobbish. "Jourdan went on a lot of family vacations with us," said Erin Sisty, whose son became friends with Bobbish when he was living in Redford.

Since learning of the teens' disappearance, Dan Sisty said his stepson has been calling Bobbish without response.

"We want to support the family," said Dan Sisty.

Erin Sisty wasn't surprised by the large crowd that gathered for the pray vigil.

"He used to live in Redford, so some teachers came. There are also teachers and friends from here," she said.

Morgan Barr, Rachel Core and Amber Wyman came to the vigil from Dearborn - they are friends with Jourdan Bobbish's older brother Josh.

"I've been close to Josh for a long time, so it was important for me to show support," said Barr.

"I'm here to show support for the family and let them know they aren't alone," said Core.

Bobbish was about to start his senior year at Churchill while Kudla had graduated and was now attending Schoolcraft College.

During the vigil, Richard Baxter - Kudla's

uncle and the last family member the teens visited - tearfully asked for help to locate Kudla and Bobbish.

"I'm really sorry for what happened. I was the last to see the boys. This is killing me," Baxter said.

When the bodies were found, family and friends were gathered expecting to resume search efforts Friday morning in the area of Joy and I-96 in Detroit near where Kudla's 2001 Chevrolet Cavalier had been recovered Monday afternoon.

The teens had gone to the east side of Detroit to visit Kudla's uncle. They left Sunday night and hadn't been seen or heard from since.

Two men were arrested for stealing the stereo equipment from the Cavalier but charges have not yet been filed. Kudla's cane, used after recent knee surgery, was found behind the apartment building where the car was located.

Where the teens went, who killed them and how they ended up across the city from their vehicle are questions that remain to be answered.

# Candidates don't like special election costs

Thaddeus McCotter's resigned his seat in Congress in July, prompting a special election that will cost in excess of \$600,000.

Most of the five Republican candidates are angry about the cost of the special election to fill Thaddeus McCotter's vacated seat, but they are also adamant that the old 11th Congressional District deserves representation over the last few weeks of the year.

Five Republicans, including a former school board member in Livonia, and one Democrat have filed to run in the special election Sept. 5.

McCotter resigned July 6, ending his term six months early after what he called a "nightmarish month and a half" in apparent reference to his duplicated signatures on petitions turned into the Secretary of State that resulted in an investigation by state Attorney General Bill Schuette. The duplicate signatures were invalidated so he fell short of the minimum signatures required to run.

On July 13, Lt. Gov. Brian Calley, acting in Gov. Rick Snyder's absence, called for a special election in the 11th District to fill the vacancy created by McCotter's resignation.

Former state Sen. Nancy Cassis, former Livonia school board member Steve King, Carolyn Kavanagh of Livonia and Kenneth Crider of Livonia filed last week to run on the Republican ballot in the 11th Congressional District. David Curson of Belleville filed as a Democrat.

The candidates had until 4 p.m. Monday to withdraw, but none of them did.

Residents in the current 11th District will be voting in a special election Wednesday, Sept. 5, and again Nov. 6 to fill the unexpired term. All of Livonia is included in both the former 11th District and the redistricted 11th District.

**'Thad ought to pay'**  
Robert Dindoffer, campaign manager for Kerry Bentivolio, said Thaddeus McCotter is to blame for the \$650,000 estimated cost of the special election to local communities. Livonia's cost is estimated at \$50,000.

"It's no one's fault but Thad McCotter's, and he ought to pay," Dindoffer said. McCotter could not be reached for comment.

Since Bentivolio filed first, he asked others not to file, Dindoffer said. If only one candidate had filed in each party, the governor would have canceled the special primary election.

Dindoffer also said another candidate had run as a Democrat in a previous state election. Steve King ran as a Democrat in the race against John Walsh in 2008. "It appears that someone is trying to manipulate the system," Dindoffer said.

Dindoffer believes residents in the 11th District should have representation, especially in a lame-duck session he expects toward the end of the year. "There is all kinds of absurd legislation that is proposed in a lame duck session," Dindoffer said.

Should Bentivolio win the special primary and special general election in the old 11th District and win the general election in the new 11th District, it will help Bentivolio better represent the district, Dindoffer said.

"He will get a couple of months seniority, which will help him get better committees," Dindoffer said.

### Cost a 'travesty'

Nancy Cassis, former state senator from Novi, said the cost of the special election was a travesty. She said she "sincerely regrets the cost and confusion" created by the special election.

"We have to explain to people why the special election is necessary and that is because Congressman McCotter resigned and created this vacancy," Cassis said. "The real key here, though, is the prevention of about six weeks that the people of the 11th District would not have representation during a lame duck session, when they will be dealing with important pieces of legislation."

"It brings about confusion and costs, but it is still a democracy and an all-important six-week session."

Crider is a steel metal worker in the heating and air conditioning field. Crider has never sought elective office before.

When McCotter didn't qualify and then quit his write-in campaign, Crider didn't like Bentivolio's views. "The only choice I had didn't represent my

views," Crider said. "I haven't voted for anyone but a Republican."

Crider believes residents also deserve the right to vote, even at the \$650,000 cost. "Government wastes a lot of money, but it's never a waste of money for people to have a vote," Crider said. "It's what democracy is all about."

### 'Law of the land'

The U.S. Constitution also requires the representation, Crider said. "It's the law. It's the law of the land."

Crider said he was contacted by some Republicans, whom he didn't identify, who wanted him to withdraw his candidacy. "I don't agree with that," Crider said. "People need to have a choice. Besides, it's the law."

Crider calls himself a "common man who can bring common sense to government."

"People are fed up with the status quo, and the professional politicians in government," Crider said.

Kavanagh, the daughter of 16th District Judge Sean Kavanagh, could not be reached for comment.

King said the election was part of the process in selecting the Republican candidates. "If they didn't like the pro-

cess, the governor, state Senate and state House, where there is a Republican majority, could have changed it," King said. "They could have changed the process."

King said Bentivolio and Cassis had already filed, so for King to withdraw at that point would not make sense for King since the election would already be scheduled.

King said "nobody said anything" about the \$10 million the state spent on Michigan's presidential primary, when the primary date was moved up to Feb. 28. "Nobody cared about that (election cost)," King said.

King also reiterated his stance on the Livonia school board that he opposed scheduling special elections in August and May, but rather scheduling them along with city or state elections to cut the costs to the district.

Since McCotter's resignation, the special election "is now a mess."

"It is confusing," King said. "I've had to educate every voter, and that's why it took so long to get signatures."

### 'Republican lock'

King said he was running as a Republican because the district is a Republican district. King believes that a Democrat will not win

the district, calling it a "Republican lock."


City Clerk Terry Marecki said notices about the election were sent to military personnel earlier this week once the candidates' list was finalized. Marecki expects that absentee applications will be mailed either Friday or Monday.

The special primary ballot will be distinguished by the date (Sept. 5 election) and by its length, as there will only be the congressional candidates listed. The primary ballot for the Aug. 7 primary election is a lengthier ballot with more candidates listed. That ballot will be turned in first.

"Thank heaven (the special election ballot) isn't a longer list of candidates and questions," Marecki said. "That would be a nightmare."

Marecki said it is possible that absentee voters will have two ballots in their homes at once, so she advised them to check the ballot and the date on it to ensure that voters turn in the correct ones on the proper dates by their respective deadlines, which is 8 p.m. on election night, both on Aug. 7 and Sept. 5.

# Ministry expects to reach million mark

Amid an effort to raise money to buy the warehouse where it helps hundreds of area families, Canton-based Open Door Ministry is expected next Thursday to surpass the one-million-pound mark for food it has distributed this year.

That signals the earliest in any given year that the food pantry has reached the one-million-pound threshold since it began helping hungry families in 2003 from a sprawling warehouse on Lilley south of Michigan Avenue.

Open Door Ministry last year didn't distribute its millionth pound of food until Aug. 24 — a sign Director Steve Darr said indicates many families across metro Detroit continue to struggle against tough economic times.

"We are ahead of last

year's pace," he said. "We are up from 410 families each week to 460. (We have) more food but more people to serve."

The latest figures put Open Door Ministry on target to distribute 1.8 million pounds of food this year, compared to 1.5 million last year.

An offshoot of Canton's Connection Church, Open

Door Ministry has drawn widespread support from other churches and a small army of volunteers who help the food pantry distribute food Thursday evenings to families in need.

One of those helpers has been the Canton Community Foundation, through which donors have been instrumen-

tal in providing financial support and amenities such as a walk-in cooler.

"Through this tough economy, we have so many hungry residents in Canton (and elsewhere) that are really invisible to us," CCF President Joan Noricks said. "Our neighbors are hungry, and Open Door Ministry has stepped up to the plate to be there and make sure there is fresh food for our friends and neighbors."

As it fulfills its mission, Open Door Ministry had a scare this year when the owner of the 48,600-

square-foot warehouse decided to sell the building.

However, the owner, Greif Inc., dropped its selling price from \$1.1 million to just \$290,000 for Open Door Ministry, which could have been forced to dramatically scale back its services if it had to move to a smaller and more costly home.

Open Door organizers have raised over \$60,000 toward the \$290,000 goal, closing a deal to buy the building amid confidence they can generate the income they need to pay

it off.

# '... We're in this together'

## Paragon company helps tenant care for seriously ill son

Everyone has someone who inspires them. For Robin Joyce, it's her son Tyler Ruffin. He smiles and never once has questioned why he isn't like other children his age. For Stacy Berninger, it's Robin Joyce because she always smiles.

Tyler is a wheelchair bound, legally blind and speech impaired 7-year-old, suffering from what doctors believe is a rare form of a neurological dystrophy. But Joyce can't be sure, since she can't afford to pay for the genetic test that would confirm their diagnosis. Medicaid won't pay for it, and the single mom doesn't have the \$3,000 to \$10,000 that it costs.

But she does have her faith and she believes in miracles like the one that happened last week when she received a check for \$3,212 from Paragon Properties, the property management company for Westwood Village Apartments where she lives.

"I'm so thankful," said the Westland resident. "When I need help and people see it and help, it helps my heart. I reached out to a lot of people for help and Paragon was the first to answer."

The money matched the amount raised by Team Paragon as part of the Make-A-Wish-Foundation's Walk for Wishes event at the Detroit Zoo in May. Tyler, his mother and 12-year-old sister participated in the event as a way of saying thank you to Make A Wish for sending the family to Walt Disney World.

"Robin is a single mom and the care she provides for her son is amazing," said Berninger, Paragon regional manager. "The Make-A-Wish charity is something dear to my heart due to family circumstances. I do the walk every year and decided to see if we could do something with Paragon."

Berninger talked with Paragon Vice President Justin Dunkel and the decision was made to match dollar for dollar the amount the team raised. Berninger sent out a proposal for donations to other Paragon properties. She was thinking they would collect \$1,500 to \$2,000 and was pleased to see it top \$3,000.

The money is going in the Tyler Ruffin Charity Hope Fund. It might not be enough for the genetic test, but it's more than enough to cover the cost of the \$300 vest Tyler needs to help with his posture.

Tyler was once a

healthy, playful and vibrant little boy, but at about age 3 1/2, his mother began to notice that he seemed clumsy and fell down frequently. She mentioned to the pediatrician that she thought his equilibrium was off. The doctor noticed he walked with a wide gait and referred her to a neurologist who found the youngster had low muscle tone.

An MRI showed that his cerebellum had shrunk, and the doctor at Children's Hospital determined that he had a degenerative condition, but wasn't able to give a specific diagnosis. Joyce took Tyler to doctor after doctor and even four neurologists. Last November, the doctors began testing him for a specific chronic degenerative condition known as juvenile neuroaxonal dystrophy, but they can't say for sure that's what he has without the genetic test.

"My son went from stumbling when he walked to crawling, he went from not being able to crawl to being wheelchair bound," said Joyce. "He had no balance, no coordination, and he couldn't feed himself. As it went on, it affected his vision. The doctors said he had macular degeneration due to atrophy of his brain."

Tyler's speech also became garbled and he drooled because of weak muscles in his mouth. He had difficulty eating and swallowing and it was determined he was at a high risk for choking, so he was given a feeding tube. He came home from the hospital with five cans of milk.

"It was very emotional to see him deteriorate. He was so small, he was only 39 pounds," said Joyce. "I couldn't sit at the table and eat and see him being fed by a tube, so I prayed and now he's eating some soft foods and no aspirating. His speech is more clear and he isn't choking as much. I see progress."

Joyce has done a lot of research. She now knows the condition is irreversible and that currently there is no treatment plan. The life expectancy for a child with the condition is 10 years.

"Every day I tell Tyler I love him more than yesterday, and I tell him we're in this together and we're going to win," Joyce said. "As long as I have the support of others, I can keep going."

The goal of the Tyler Ruffin Charity Hope Fund is to raise money to cover the cost of genetic testing that is not covered by Medicaid and provide funding for his

medical needs and adaptive equipment. Because of his illness, Joyce hasn't been able to work, so gifts like what she

received from Paragon are greatly appreciated. "Words can't ever express how much I appreciate Paragon

for stepping up to the plate for me," she said. "They're my family."

Admittedly, the past four years have been a journey of faith and believing. Joyce has faith God will help Tyler and direct her to people and agencies that will help her. She also believes in miracles. After all, she is

"fighting for Tyler's life."

"I wrap his pinkie around mine and ask him what he promises and he tells me he'll never give up," said Joyce. "I tell him this is a fight, and he says we're in it to win. I don't focus on what could have been. I believe Tyler's life is in God's hands and every day I trust in God."

Berninger said Paragon is now looking to do other things like something for the Michigan Humane Society in August or September and do the Make-A-Wish walk again next year.

"Robin and her family are so positive," said Berninger. "Robin takes it day by day and always smiles. She's inspired me to do something for others."

# Swifter, higher, stronger


For a few short weeks the world can try to put the monetary crisis on the back burner and focus on the greatest international competition known to humans – the Summer Olympics.



# FAST helps parents and teens communicate

Gloria Allen didn't think she had a problem communicating, but after FAST, she realizes she wasn't communicating with her son.

"I had lost power with my child, he was out of control and over the top," said Allen. "What was I going to do with him? With FAST, I found it was good to know I wasn't in this party on my own. I learned how to listen to my child and how to spend quality time with him."

Allen was among a group of families who accepted the invitation to participate in the inaugural Families and Schools Together program offered to Garden City Middle School students and their families through the Garden City Resource Center.

The FAST program is funded through a grant from the Michigan Office of Juvenile Justice and Delinquency Prevention, and targets preteens and teens in sixth-eighth-grades.

"We were required to select from four programs and we chose FAST because it was one we could do with schools," said Resource Center Director Monica Fulton. "All data indicates that middle school is where we need to target our prevention work."

Work started last November with the training of the FAST team which recruited youth for the program during lunch hours at the middle school. Seventeen students took permission slips home, but only 10 committed to the program.

The program includes a

youth and parent groups as well as family sessions. According to Fulton, the youth group is "peer driven."

"It was what the kids wanted it to be," she said. "It was a safe environment to talk about what they wanted to talk about."

The 1 1/2-hour family session included dinner that was prepared by a different family each week. The youth group


met, there was buddy time for parents and then a one-on-one with the children on a topic they selected.

"We had a dinner lottery and a family name was drawn," said Fulton. "They got a gift basket with gift cards for Kroger and Target and a crock pot on loan. There were also things for the family and kids like games, iTunes cards and planners."

Allen's son Marty admits that he and his mother weren't really talking to each other.

"By going through the program it got better," he said. "Now my mom likes to spend time with us and get to know us better."

"I didn't want to go because I have more things happening in my life that I didn't need another program, but I looked forward to Wednesday evenings,

I enjoyed the one-on-one," Gloria Allen said. "I thought it was going to be nice and friendly. It didn't deal with nice and friendly situations, but he needed to get it off his chest."

Terry Lukacs found the FAST group "amazing." She was in the program with her daughter Paige Walker.

"I meet a whole bunch of families with the same problem," she said. "I went in feeling like I was the only one with a problem and I wasn't. Through their different experiences, I learned how to communicate with my child. She understands me more and I understand her more."

"I liked one-on-one because I could talk and not have rules," said Paige. "I think we've change some because we communicate more."

Melissa LaBean swore she wasn't going to cry, but was in tears her first FAST meeting. Her son Tyler wasn't sure he wanted to go, but as the meetings went on, he got to like it.

"Tyler talked to other friends and they told him the first few weeks are going to suck, but after a few weeks, Tyler saw how we were communicating and not fighting at

home," she said. "It was a good experience. We had a lot of issues and as we went through the program they got better and better."

Chris Daniel, director of training projects for FAST Inc., was impressed with the resource center's program. Daniel, who was at the Maplewood Center for the FAST certification dinner, said one of the things that made it a success was getting of the FAST team.

"You heard it in this room tonight," he said. "Three months ago they wouldn't have felt comfortable expressing personal things. They felt confident sharing their experiences and weaknesses. This was a good group, a very good group."

The program is nearing the end of the first year of the grant and Fulton said the resource center will be able to offer another program in the fall. The team will start recruiting students during schedule pickup next month. The youth group will start meeting on Sept. 13.

"It's really awesome," said Fulton. "It's a great opportunity."

# Slavens calls for election reform, speaker step-down

State Rep. Dian Slavens is urging reforms to election and campaign laws and calling on GOP House Speaker Jase Bolger to resign in the aftermath of an alleged effort to rig a state legislative race by paying a fake Democrat to enter the contest.

Slavens, D-Canton, also is suggesting a probe by the House Committee on Ethics and Elections into accusations Bolger and state Rep. Roy Schmidt orchestrated Schmidt's 11th-hour defection to the Republican Party to seize victory in the Grand Rapids race.

"House Speaker Bolger broke the public's trust," Slavens said, as a crowd of 25 supporters joined her Thursday afternoon during a press conference inside the Canton Administration Building.

### Lashing out

Slavens and other Democrats lashed out at Bolger and Schmidt amid mounting criticism over allegations Schmidt offered \$1,000 to a fake opponent whose ultimate decision to withdraw unraveled the effort.

Kent County Prosecutor Bill Forsyth criticized the scheme but said it didn't violate any laws.

Ari Adler, Bolger's press secretary, said by telephone from Lansing that Bolger "has no intention of resigning his position" after authorities ruled no laws had

been broken.

However, Bolger and Schmidt have apologized for efforts to fool voters, and Adler said Bolger is willing to look at proposed election-reform bills regardless of which political party proposes them.

That's not enough for voters like Shirley Poling of Westland, who came to Slavens' press conference.

"There is a pattern of abusive power developing," Poling said, adding she was angry for Bolger's earlier role in muzzling two female legislators for statements they made in a debate on abortion and reproductive rights. "This situation speaks of such a lack of character and ethics."

### Broken trust

She said Bolger and Schmidt should pull out of politics for "creating distrust in their constituency. I find that reprehensible."

State Rep. Kurt Heise, R-Plymouth Township, said legislators on both sides of the aisle in Lansing have suggested new legislation following the scandal involving Bolger and Schmidt.

"I'm always ready to take a look at any legislation that helps to clarify the process," he said. "I want to make sure that, whatever we do, it does not decrease access to candidates to run for office."

"I think everybody would be interested in making sure the process is tightened up for every-

one," Heise said. "I think both parties are looking at ways to clarify this situation in the future."

Slavens, who faces Democratic challenger Kiz Ahamiojie in the Aug. 7 primary election, touted a series of bills she said could deter actions such as those by Bolger and Schmidt. The laws, if enacted, would:

- Increase fines for committing election fraud from \$1,000 to \$10,000.
- Provide a later filing deadline if a political party loses a candidate within seven days prior to the cutoff. The party would have 14 additional days to pick a candidate of its choosing.
- Bolster residency rules by requiring state legislative candidates to live in their district for at least 60 days prior to running for office.
- Require candidates

who switch political parties to return all campaign contributions they received during the last year.

Force party-switching candidates to disclose the change during any fundraising effort.

Require legislative and other candidates to file their affidavits for candidacy in person, rather than sending someone else.

Force incumbents to file one week earlier for re-election, giving challengers an additional week.

### Denied fairness

"This is not just a Grand Rapids issue," Slavens said of the Bolger-Schmidt scandal. "This is a matter of every citizen of Michigan having the right to an open and accountable democracy."

Slavens said an estimated 90,000 people in the 76th District have been denied a fair election because of what happened.

Slavens said the latest set of bills follows earlier efforts by Demo-

crats to adopt reforms, but she said Republicans have "stonewalled" changes.

"People like House Speaker Bolger just don't get it," she said.

Some Republicans have drafted legislation, however. One bill by state Rep. Tom Hooker, R-Byron Center, would extend the candidate filing deadline by five days if a candidate switches parties or withdraws during the last two days before the cutoff.

Slavens called on voters of all political parties to demand change to avoid another scandal.

"We need everybody in this great state to stand up and say enough is enough," she said.

What Bolger and Schmidt did may not have been ruled illegal, Slavens said, "but what was done was unethical, and we want to change that" through new legislation.

Canton resident Leonard Zabawski, who attended Slavens' press conference, agreed.

"Democracy is important," he said. "We need to keep democracy, transparency and ethics so there is no fraud or rigging of elections."



## Paying off mortgage with lump-sum withdraw may have tax consequences

**Q:** Dear Rick: My wife and I have a dilemma that we hope you can help us with. We are in our early 60s and are both retired. At this point we are not taking Social Security and plan to delay that a couple of years. Currently, my pension and my wife's severance more than cover our living expenses. We have a \$150,000 mortgage on our home. The interest rate is 4.5 percent and we have approximately 15 years left. For many reasons we cannot refinance. My wife is more

conservative than me and she would like to take the money out of our IRA and pay off the mortgage. I think with interest rates so low it doesn't make sense to pay the mortgage off. What do you recommend?

**A:** I don't want to come between you and your wife, however, I think it would be a mistake to withdraw the money in one lump sum from your retirement account. My reasoning is based on when you withdraw the money, it is subject to ordinary income tax; which means you will lose a significant amount of money toward taxes. Withdrawing the money in one lump sum would also throw you into a higher tax bracket. I believe that money

should be used to increase the quality of your life. If having the mortgage paid off would do that, I would recommend to do it over a five-year period. Based upon the number you provided and upon current tax laws, you could make a lump-sum payment of approximately \$25,000 per year for the next five years. Coupled with your current payment, you would have the house paid off in five years. Doing it this way would not throw you into a higher tax bracket. One question I'm frequently asked is whether it makes sense to pay off mortgages.

As far as I'm concerned, there are two ways to think about this issue. The first is purely from a financial standpoint. Look at what the mortgage is costing after tax, versus money earned after taxes, if invested. If, for example, the mortgage, after taxes is costing 2 percent and after taxes that money was earning you 4 percent, from a financial standpoint, it would make sense to keep the mortgage. On the other hand, if the after tax cost of the mortgage was 4 percent and you were earning only 2 percent on your money, paying off the mortgage would make

sense. Some people sleep better at night when their homes are paid off. In that regard, it's not a financial decision, but a peace of mind decision. In those cases where people will feel more comfortable by having their house paid off, it does make sense to work on a program to accelerate the mortgage payments. Never forget that money is a tool that is used to increase the quality of your life. The goal is not to accumulate as much money as you can but to live a fulfilled life. Money is a tool that can assist you. That doesn't mean we don't have to

watch our money and be vigilant with it; but rather, it should never be the end withal. One of the challenges in life is to balance quality of life versus the reality of our finances. If you let the scales tip too far in either direction that is where problems will develop. I wish I had an easy answer, but I don't; what I do know is that it is possible to have that balance. Good luck!



# Now hear this: Avoiding swimmer's ear

If your kids love to splash-splash summer away playing in the water, chances are they're at greater risk for a condition called "swimmer's ear" or otitis externa.

Garden City Hospital's Dr. Gregory Stephens, who specializes in otorhinolaryngology (ear, nose and throat), oro-facial plastic surgery and allergies, can help parents recognize and treat this all too common infection.

**Q: What causes swimmer's ear?**

**A:** First, it's important to understand that two types of ear infections mainly affect children - otitis media (middle ear infections) and otitis externa (external ear infections like swimmer's ear).

Swimmer's ear is actually a skin infection caused by bacteria commonly found in soil and water that has invaded the thin skin of the ear canal. It's closely associated with swimming because that's when patients most often get water in

their ears.

People can also get swimmer's ear because they used a cotton swab too harshly in the ear canal, scraping the skin, and thereby exposing the ear canal to harmful bacteria. (Save cotton swabs for cleaning the outer ear only.) Don't use cotton swabs or other objects in the ear canal; they compress the wax and create a groove where water can accumulate. Unfortunately, some people are predisposed to getting chronic swimmer's ear.

**Q: What are the symptoms?**

**A:** Symptoms may not appear for several hours or even for a couple of days after exposure. There may be mild to moderate pain, low-grade fever, throbbing, swelling in the ear canal, even partial hearing loss (hearing will improve after the infection has been eliminated). Other symptoms include itching, drainage from the ear and impacted

wax.

**Q: Why are kids at increased risk?**

**A:** Children spend more time in the water and have smaller ear canals, which can trap wax and water more easily. Unfortunately, Mom or Dad may try to help by cleaning out their youngster's ears with cotton swabs, which can lead to swimmer's ear.

**Q: What is the recommended treatment?**

**A:** We use the basics of chemistry to treat the problem. An acidic drop (containing vinegar) is used typically four times a day. Other antibiotic-containing drops may be used as well. Oral antibiotics are not usually indicated to treat otitis externa. And if the ear canal is swollen closed, a wick (sterile, compressed sponge that gently expands within the ear canal, dispersing medication) may be required to get medicine into the ear

canal.

**Q: Is this a serious infection?**

**A:** Usually, no. Swimmer's ear is a very simple problem if treated early and appropriately. If left untreated, it can turn from a bacterial infection to a fungal infection, which is especially bad for diabetics. If the ear canal infection goes beyond the eardrum into the middle ear, then it could potentially cause middle ear problems. This would be extremely rare.

**Q: Left untreated, can swimmer's ear become dangerous?**

**A:** Normal, healthy patients shouldn't have an issue. Typically, the pain is enough to get patients to the doctor well before it becomes dangerous. Diabetics and people with weakened immune systems are at greatest risk of developing malignant otitis externa. In this condition the infection spreads to the

surrounding bone and can get into the blood.

**Q: Is wax in your ears a good thing?**

**A:** Yes. Wax, which is an acidic substance, is nature's defensive weapon against infection. If your ears are exposed to a lot of moisture, the wax gets thinner, less acidic, and the ear canal turns into an even more hospitable home for bad bacteria.

**Q: What is a safe way to clean your ears?**

**A:** If you're certain that you don't have a hole in your eardrum, it's OK to use a mixture of white vinegar and hydrogen peroxide (50-50) to rinse inside the ears. I would avoid using water because if it becomes trapped behind some wax that you failed to remove, the chances are high for developing an infection.

**Q: Does chlorine in swimming pools help protect against swimmer's ear?**

**A:** Chlorine is a disinfectant that prevents the growth

of bacteria and algae. The acid base balance of the pool will determine if chlorine can actually do its job effectively. Chlorine works best in a neutral environment, and if the pH is neutral, chlorine destroys bacteria on contact. However, I haven't read anything that specifically says chlorine prevents swimmer's ear.

**Q: Is there a good way to prevent swimmer's ear?**

**A:** First, it's essential to keep wax from building up. During routine visits, your doctor should inspect and remove any wax that might cause a problem. If the ear canals are clean, then they should drain without too much of a problem. Anyone who has had problems in the past might benefit from earplugs while swimming.

Sunday through Tuesday at Fox Hills, and then plays golf Wednesday through Saturday.

He also plays in a Friday league at the Fox Classic Course.

"I really don't keep a handicap," he said. "But we have a secretary and we keep all the score sheets in the Saturday league and mine is 17."

### Going long

Clack, who has been a league director for 35 years, credits his recent success to a newly purchased Taylor Made driver and 3-wood. He plays with a senior-flexed set of Wilson fat shafts.

"Let's say there are 15 entries in a particular class," he explained. "They'll run an elimination and eliminate certain people by the way they place and wind up with a final group of racers."


"Out of those racers you will have a winner."



"I'm getting more distance," Clack said. "About 15-20 years, more than I've been hitting. Normally I'll hit the ball out there maybe about 185-190 off the tee. I get it mostly down the middle all the time because the shorter you hit the ball. The better control you have on it."

He managed baseball in Garden City for 28 years, including six years of little league before moving up to Babe Ruth (with his son Rick, who is currently the Livonia Franklin girls tennis coach).

He also coached Connie Mack baseball (ages 16-18) and he organized the Garden City Class A Invitational league where he directed that league for 15 years.

"Anybody could play in that league," Clack said. "I myself started playing in that particular league when I was 49 years-old and played until I was 63."

At the age of 62, Clack proved he was the Satchel Paige of the Garden City Class A circuit once pitching all nine innings and winning against an all-star team from

Detroit that featured five ex-Major Leaguers.

On Thursday, Clack proved his round of 70 was no fluke as he carded a 76 on the same Links of Whitmore Lake.

Clack said he has never taken a golf lesson and basically learned the game on his own. He's had five hole-in-ones in the "last six or seven years," but only two came when he had witnesses.

"I've playing since World War II," he said. "I'm playing pretty good golf right now. I'm in excellent health. I weigh about 165 pounds and I go about 5-foot-9. I don't smoke and do a lot of exercise working outside of Fox Hills. I go to the Summit (Parkway) and walk in that indoor track. I walk every day and walk a mile, so I keep myself in pretty good shape."

He's taken a page from Paige's book when it comes to golf and living when he was quoted saying: "Don't look back. Something might be gaining on you."

Dil Clack apparently isn't looking back.

ant, a 6-4 forward via Grayson H.S. in Loganville, Ga.



last month in Omaha, Neb., she broke her own American record in the 200 free with a mark of 1:54.40.

### Still the same

Weber said Schmitt seems to still be the same fun-loving girl who enjoyed joking with her teammates almost as much as coming from behind in a relay to drench the competition.

"The respect factor that we hear other coaches and other athletes talk about Allison really go right in line from our experiences," Weber noted. "So she hasn't changed a bit. When you hear the interviews with other athletes, you hear how Allison is fun to have at practice.

"She's always in with the jokes, excited to be there. We had that day in and day out for four years."

Looking back on when Schmitt started her Canton career as a high school freshman, the veteran coach recalled how much potential she had.

"She came in as a freshman very excited about swimming," Weber said. "She still hadn't had the big breakthrough."

Others saw it, too.

"Chuck Olson, the Salem coach, he came up to me as she was a freshman," Weber continued. "And he said after one of the first times he got to see her swim was 'She can do things in the water that I have never seen before.'

"And what he meant by that is the way she can grab the water, (get) her elbow up underwater and pull herself up and over."

While Schmitt was a sophomore, Weber and Raines kept working with her on breakouts and turns.

"You could see her finding that niche after her sophomore year," Weber said.

"She started to make her Junior Olympic team and it proceeded on to winning state meet her junior year, winning state meet her senior year.

"She was second place in the 50 and 100 (free) her sophomore year and right after that some magical switch happened. She went from being an excellent swimmer to being the swimmer we know now."

### Gold's the goal

As great as she swam for the Chiefs, Schmitt really took off after she graduated. She nabbed a bronze medal in the 2008 Beijing Olympic Games in the women's 4 x 200 relay.

From there she went to the University of Georgia, where she became a four-time NCAA champion.

But in the next two weeks at the London Olympics, Schmitt will be focused on bettering 2008 by winning a gold medal or two.

That could be next for a supreme athlete who Weber recalled having an absolute disdain of defeat.

"There are just tons of stories about how she would come back on a relay," from a length or more, Weber said. "We often put her fourth, because Allison hated to lose."

With Schmitt's talent and fierce mindset, it's no surprise she's on the world stage once again — and that those in her hometown who had a part in her career also feel like a winner.

## Twenty years later, Livonia band continues to entertain

Five hometown boys and Bentley High School pals are proof you don't have to be Hollywood or New York City to be successful musicians with a considerable following.

"We don't have any grand illusions. We are just having fun," said Greg Panaretos, one of five original members of the popular The Major Woody Band.

Graduation, marriages, children and jobs kept the friends busy over the years; some staying in touch and playing music together. But in 1992, Glen Dickson decided it was time to make their continuing love of music official and organize a new band.

One element, however, was missing for the five friends who gathered now as adults to venture into a professional world of music. The new band needed a name.

### The name

Founding member Carl Gerhard one day just said it: "The Major Woody Band."

The name has stuck. "Back in the day, we were just throwing names around. It really doesn't mean anything. It's just a silly phrase," Dickson said.

Still, the name is interesting enough to draw the requisite attention from fans in the region. Of course, good music is what keeps the fans coming back for more.

The Bentley High School grads just took down the house at the Livonia Spree Festival and continue to be

booked throughout the year at the region's favorite clubs.

Now in their late 40s and early 50s, band members are celebrating The Major Woody Band's 20th anniversary. A milestone to be sure, but members

also recognize the length and depth of friendships and a commitment to playing good music.

Right out of the gate, original Major Woody members Michael Wigand, Dickson, Carl Gerhard, Chris McCro-

ry and Panaretos agreed they wanted to be known for being different.

"We like all music but we wanted to play alternative music," Panaretos said.

When the decision was made to include the Motown landmark, *I Heard It Through The Grapevine*, it wasn't the popular Marvin Gaye version, but a more soulful rendition by Gladys Knight & the Pips.

Heavy rock-and-roll and some punk also captured the band's interest. But as Dickson said, "we knew that if we wanted to be successful and make money we would have to play dance music and some of the classics."

When band members

say classics, however, they aren't necessarily talking about imitating music on mainstream radio. It's not exactly "oldies but goodies." They sing classic artists, but not necessarily the songs that made them famous.

"We really do off-the-wall classic. We don't do the usual," Dickson said. "We really try to stay new."

### Staying true

The band does their homework, searching for new music that will be a hit with their fans. "We try to stay true to the recordings and the artists because we also want the music to be recognizable," said Tim McPherson.

son who joined the band six years ago.

If the musicians' wives like dancing to their selections, the songs stay in the repertoire. "Our wives have good taste in music," Panaretos added.

Twenty years later, Major Woody has remained true to its roots. Friendship, family and a love of good music continue to sustain the band and the relationships forged long ago as teenagers. It is also a part-time gig for the band. Each member has a day job and each works on their own for practice and for searching new music.

Along the way new members have joined the band, bringing what Panaretos calls a new kind of professionalism.

Joining the original five members is Tim McPherson, Mark Lutzo, Duran Grisa and Carrie Firth, the lead vocal and a special education teacher for the Livonia Public Schools. McCrory of the original group has left as has Susan Harwell, who sang with the group for a while.

Each of the members gives credit for their musical success to their alma mater. "Dr. (Jerry) Smith (music teacher) and Bentley High School — there's a lot of talent in that school," Dickson said.

### Sell it

It was Smith who not only taught them music, but an important fact about the business. You have to sell it. "Now it's Glen who tells us that," Panaretos said.





It's one thing to make good music, it's another to play and present it in a way that keeps people coming back for more. The show has to be entertaining.

"You can get sucked into the vortex," said McPherson, who followed the band before he joined it. "The crowds have a good time because they watch and see us having a good time."

That means constant change and searching for music that can be universally appealing to the 25 to 65 age group. It is the reason The Major Woody Band plays a wide variety that includes David Bowie, some Motown and even Lady Gaga.

"We try to stay on the edge," Panaretos said. "But maybe not exactly the way people have heard it before. We will have people say to us, 'who did that music or I haven't heard that in so long,'"

The music is an art, but so is finding the right venues. McPherson tends to handle that task. But it's more than just scheduling a gig. He prefers to create partnerships with clubs and owners. It creates longevity and trust.

Weddings and other functions remain a part of the band's venues. Members try to personalize the music program for the guests of honor. At one wedding, band members invited the groom to bring along his trumpet and play with them.

Despite its success, the band was floored with the reception it received at the latest Spree in Livonia. "Between sets, I couldn't say hello fast enough to all the people I knew who were coming in," Panaretos said.

It's been 20 years and nothing has dampened band members' spirits. "We are very loyal to Livonia. We will still be doing this when we are all 97," McPherson said.

# Aviation artist's work selected for Air Zoo

Robert Aikins, a Farmington Hills resident and a member of the American Society of Aviation Artists, will show two paintings in the ASAA 2012 International Aerospace Art Exhibition at The "Air Zoo" Aviation Museum, in Kalamazoo.

Aikins was one of 51 artists from around the world whose work was selected for the show, which runs through Sept. 8.

His works, titled *Showtime* and *Target Toyama* depict both the beauty and horror of aviation history.

Last year, he was accepted as an Artist Member of the American Society of Aviation Artists with work exhibited at the National Naval Aviation Museum in Pensacola, Fla.



## WHEN DRUGS WON'T DO

If your car develops a new noise, you take the care to a mechanic with the question what does this new noise mean? Often the mechanic, after inspecting the vehicle, can tell you that the engine is fine, the brakes are in working order, the cooling system is passable, and nothing is loose under the hood or car. In short, the auto is good to go. Still, he may be unable to tell you why you have the noise, and will conclude with the advice to live with it.

A similar situation can occur with the body, particularly with the joints, muscles and their attachments. If you suddenly have a new pain that persists, in the area of your knee or hip, you have a reason to question if the problem is a strain or even possibly a cancer? Making a doctor's appointment is an exercise in good sense.

Your physician then has the responsibility to evaluate the pain. By a combination of examination, laboratory and imaging findings such as x-ray, CT and MRI scanning, the physician usually can provide answers to your concerns.

In some instances, he may conclude in a manner akin to the mechanic's answer. The pain does not represent an injury, a tumor or cancer, is not an infection, and does not reveal arthritis such as rheumatoid arthritis or lupus. The problem is not potentially life threatening or crippling, nor represents another condition needing medical attention.

The treatment of choice for this pain is to do nothing, a conclusion as important as uncovering a cancer, a conclusion that should not be a disappointment, but a relief.

## Helping seniors drive safer, longer

Since January 2011, nearly 10,000 Americans turn 65 every day, joining the fastest growing age group in the nation. According to a recent American Automobile Association (AAA) survey of that booming population, nearly half of seniors worry about losing their freedom and mobility when the time comes for them to transition from driver to passenger.

From understanding how vision changes can affect one's ability to drive at night, to researching the effects certain medications can have on one's driving ability, it's important to get the facts about driving for seniors. Use these tips from AAA to help ensure you and your family members are driving safely.

### Evaluate your driving.

While most seniors are experienced drivers, it's important to take time to consider one's driving "health" and habits. For instance, how frequently do you wear a seatbelt? Do you use your signal and check for nearby traffic before changing lanes? Does traffic cause you to feel anxious? When was the last time you had an eye exam? ### Be aware of how aging affects driving habits.

From hearing and vision loss, to mental fitness and



reaction time, seniors may not notice the gradual differences that can impact their driving ability. For instance, by age 60, your eyes need three times the amount of light to see properly as they do for people 20 years old, which means it's more difficult to see at night. Likewise, one-third of Americans suffer from hearing loss by age 65. This can pose a problem, as senior drivers may be unable to hear high-pitched noises such as emergency response vehicles while on the road.

Reaction times can be slower for seniors as well. But preventative measures can go a long way. — When following other vehicles, seniors should increase the distance between their car and the car in front of them, to allow more time to react to sudden braking.

— Eliminating distractions in the vehicle and avoiding heavy traffic can also help seniors identify emergency sirens, and avoiding driving at night is another safer option for seniors.

### Find the right fit.

With the wide array of vehicles offering all sorts of convenience features, seniors may not realize that their car may not be optimally adjusted to fit them. For example, sitting too close to the steering wheel can interfere with steering and cause fatigue, as well as injury, should the airbag deploy during a collision.

— Make sure you have at least 10 to 12 inches between your chest and the steering wheel.

— When seated properly, you should be able to see the ground in front of

your car within 12 to 15 feet and 1 1/2 car widths left and right.

— Visit [www.car-fit.org](http://www.car-fit.org) to assess the safety of your vehicle, find the proper seat and mirror adjustments and more.

### Take a refresher course.

No matter how many years a driver has been on the road, a refresher course can help reinforce the basics such as identifying road signs, as well as provide information on updated driving rules and new vehicle technologies.

### Talk with your doctor and pharmacist.

Ensure that the medications you take — both prescription and over-the-counter — will not impair your ability to drive safely.

In addition, make sure all your medications go through one pharmacy, so the pharmacists on staff can better assess any potential drug interactions.

### Top 5 driving tips for seniors

1. Prepare for a drive by adjusting your mirrors and seat to ensure you can see properly. Always wear a seatbelt.

2. Eliminate distractions, such as the car radio, which can interfere with your ability to hear emergency response vehicle sirens and other important sounds.

3. Avoid driving in bad weather, heavy traffic or at night.

4. Making left-hand turns can be difficult for people with limited vision. Avoid left-hand turns at

intersections with signals by making three right hand turns around the block when possible.

5. Manage slower reaction times by increasing the amount of space between your vehicle and the car in front of you, allowing for more time to react to sudden braking.

### Tips for family members

If you're concerned about the safety of a senior family member, look to resources such as their doctor or your local DMV, that can help identify their capacity to drive, and find transportation resources to help them manage daily needs:

— If your family member has received two traffic citations, warnings or been involved in two collisions or "near misses" within a two year period, it may be time to look for other forms of transportation.

— Make sure your family member speaks with their doctor and pharmacist about prescription and over-the-counter medications that may impair their ability to drive safely.

— Talk with family members, friends and neighbors about organizing a car pool to help seniors who need rides find transportation. Look to local public and supplemental transportation options as well.
